2. President's Report

In addition to the written report provided, President Agnew highlighted:

- fall 2021 term: strong enrolment numbers with 7.6% growth in full-time enrolment in comparison to fall 2020
- winter 2022 term: domestic applications are down but international enrolment continues to be strong

- reopening campuses: slow, gradual, cautious approach with the number of students on campus; ongoing discussions to reopen more spaces for students to use when on campus
- vaccination policy: all individuals coming on campus must be fully vaccinated by Saturday, Oct. 30 as grace period for partial vaccination with rapid testing will end; policy will continue for winter 2022 term; individuals who have received exemptions have not been permitted to come on campus and have been accommodated in other ways
- planning for 2022-23: planning underway for transition to post-pandemic operations; focus will be on equitable Seneca, sustainable Seneca and a more virtual Seneca in the post-pandemic academic delivery and service delivery modes and continuing to improve digital strategy
- capital planning: construction of new health and wellness centre at Newnham Campus and replacement of Garriock Hall at the King Campus
- Seneca Au Large:
 - work continues with equity, diversity and inclusion (EDI) committee with the student census being launched this fall and the review of policies and training programs
 - o Seneca's sustainability plan is now in place and the Office of Sustainability is being established
 - o flexible work meetings being held at the department level to confirm details of remote work approach
