- The announcement of the Reconciliation and Inclusion Plan, a three-year plan to help guide the Seneca community to continue work to embed reconciliation and inclusion within its culture, governance, spaces and the education it provides, which will take Seneca further into the journey to become equitable
- The pandemic-specific health and safety restrictions on campus will be removed as of May 1, 2023
