ELIGIBILITY CRITERIA

To apply for Seneca's FSE Bridge Training Program, applicants must meet the following minimum criteria:

1. Applicants are internationally trained individuals with a post-secondary degree or diploma.
2. Applicants are internationally trained Canadian Citizens, Permanent Residents, or Convention Refugees.
3. Canadian Language Benchmark (CLB) Assessment at Level 7 (preferred).

APPLICATION PROCESS

- Letter of Interest
- Resume
- Proof of CLB Assessment
- Immigration Status documentation
- Copies of Academic Credentials (degrees, diplomas, and/or certificates)
- Copies of Credential Assessment (if available at the time of application)
- Completed Application Form (see following pages)

1. Letter of Interest:

Your letter of interest should be 1 page single spaced (maximum) and address the following questions:

- A. Why are you interested in the FSE Program?
- B. What do you hope to gain from your participation in the FSE Program?
- C. Why do you think you are a good candidate for the FSE Program?

2. Resume:

Your resume must be detailed and updated (2 full pages is ideal, 3 pages maximum). It must be in a chronological format, beginning with your current or most recent employment. Please be sure to include the following:

1. All employment that you have held, whether in your field or not, with clear bullet point explanations of your responsibilities and accomplishments
2. All academic qualifications (exact names of degrees, certificates, diplomas, etc), including any education completed in Canada, with dates
3. Professional memberships, licenses, designations, etc
4. Any professional training or skills upgrading that you have completed in or outside of Canada including names of institutions and dates attended.

3. CLB Assessment:

You will need to provide proof of completion of a Canadian Language Benchmark Assessment at Level 7. CLB Assessments should be obtained within the last 12 months from the date of application to be valid.

CLB Assessments accepted by the FSE Program include the following:

- CLBA
- CLBPT
- ELTPA
- WLA

CLB Assessments are free for Permanent Residents, Convention Refugees and Canadian Citizens.

4. Immigration Status:

You will be required to submit a copy of one of the following: Citizenship Card, Canadian Passport, Permanent Resident Card, or Proof of Refugee Status.

5. Copies of Academic Qualifications:

Please provide a proof of all of your academic credentials in your submission, (copies of any diplomas, degrees and/or certificates).

6. Academic Credentials:

If you are accepted into the program, you will be asked to provide credential assessment results from an approved credential assessment agency. For more information on approved credential assessment services, please visit the Canadian Information Centre for International Credentials website.
